Christmas of 2017 Mar a Lago:

Subject #4 Truth Social & Trump Media

Truth Social and its parent company Trump Media are currently operating as communication instruments put in place to allow those who profit off hate, racism, antisemitism, and bigotry to utilize a newly formed dark web to do business. Hudsucker Nexis Industries has had over two dozen confidential volunteers and other assets become users on Truth Social for the purpose of exposing the dark truth behind Truth Social which is the following:

- 1. Users who attack and or threaten Former President Trump have their accounts temporarily and or fully suspended, and or banned.
- 2. Users who attack and or threaten President Joseph Biden are applauded and awarded with special perks.
- 3. The users who have their accounts suspended and or fully suspended and or banned, receive threats via email, text message and phone call periodically.
- 4. Those who are considered loyal users and or Trump Loyalists are offered access to illegal means of communication with those who would be domestic terrorists.

Truth Social and its parent company Trump Media have been investigated since their inception in 2020 / 2021. Confidential informants have visited Truth Social / Trump media offices in Sarasota, Florida and the unknown offices in Palm Beach, Florida and New Jersey. Visual and documented proof has been obtained showing that Truth Social / Trump Media's latest expansion on to the New York Stock Exchange was orchestrated by Russian businessmen and a former KGB agent with close ties to Russian President Vladimir Putin. Furthermore, one of the Russian individuals is directly tied to the fraudulent testimony about Hunter Biden.

MAR-A-LAGO SECRET DINNER

March 15th 2025 / AIR FORCE ONE

Two highly confidential insiders aboard Air Force One held conversations with Elon Musk, Stephen Miller, and President Donald Trump during flight from Andrews AFB to Palm Beach International. The substance of both conversations consisted of information regarding the bombing in Yemen which had taken place just hours earlier.

Confidential insider (1) whose official capacity and position we cannot divulge, held a brief ten-minute conversation with President Donald Trump near the Presidential quarters. During the conversation, President Donald Trump boasted about the recent bombing, and said that certain members of this cabinet were so excited about the attack that certain members of the media took part in a live communication before and during the attack. Insider (1) asked President Trump which members of the media took part in the communication, but President Trump declined to answer. President Trump told insider (1) that the mission was a success before being interrupted by Stephen Miller regarding an incoming phone call from Pete Hegseth.

Confidential insider (1) then continued to speak with Stephen Miller after President Trump excused himself to speak with Pete Hegseth. Insider (1) asked Stephen Miller about the bombing and about the addition of members or a member of the media being part of a conversation before and during the attack on Yemen. Stephen Miller said that President Trump had a secret list of a few handpicked journalists which the President has given high level access to for certain situations such as the communications before and during the Yemen bombing. Stephen Miller continued to say that President Trump was unhappy with Pete Hegseth due to reports from two other cabinet members who told President Trump that Pete Hegseth seemed to be out of it, and or under the influence during a cell phone conversation shortly after the attack had taken place.

Confidential insider (2) held a lengthy conversation with Elon Musk during the flight from Andrews AFB to Palm Beach International regarding the following subjects:

- 1. Doge
- 2. Yemen Attack

Insider (2) asked Elon Musk about activities and plans being carried out by Doge. Before Elon Musk began answering insider (2)'s questions, he said "Let me make myself perfectly clear. Doge is nothing but a massive smoke screen and a tool to dismantle and destroy the federal government per President Trump's specific plans and instructions." Insider (2) asked Elon Musk what he meant by a smoke screen, and Elon Musk said "President Trump, myself and certain members of his cabinet, his family and a select few billionaire investors are cherry picking and scavenging nearly five trillion dollars."

Insider (2) then asked Elon Musk about Doge's staff which insider (2) said seemed to be a highly unusual selection for such critical and secretive government work. Elon Musk told insider (2) that President Trump told Elon Musk to utilize younger individuals who would do as they are told, and to make sure that not only did each individual have a background in finance and tech, but that they were skilled hackers and or of the criminal element.

Insider (2) then asked Elon Musk if he knew anything about the recent attack in Yemen. Elon Musk said that he knew all about the attack, and that he took part in several communications between President Trump, Vice President JD Vance, Pete Hegseth, Susie Wiles and Mike Walz. Elon Musk also said that President Trump was extremely angry about a reporter from the Atlantic being part of classified Signal conversations before and during the attack on Yemen. Insider (2) asked Elon Musk about the Atlantic reporter, and Elon Musk said that President Trump, Stephen Miller, Susie Wiles and Vice President JD Vance were coming up with a plan to make it look like the reporter hacked the Signal chat as part of the radical left's plan to destroy President Trump.

The conversation between insider (2) and Elon Musk ended when Stephen Miller pulled Elon Musk aside, asked him "what the hell are you doing" and then said that President Trump wanted to see him. Before Elon Musk walked away he did say that two addtional Signal Chat conversations and three phone calls between Pete Hegseth, his wife, his brother, a close family friend and two attorneys, were being investigated and covered up by the White House.

Evening of March 15th / Mar-a-Lago

Multiple long term embedded confidential informants and trusted insider's aka Mar-a-Lago employees witnessed and personally took part in multiple in person conversations with President Donald Trump, Donald Trump Jr., Elon Musk, Stephen Miller, and Marco Rubio. Two confidential informants also witnessed and overheard a phone call between President Trump and Mike Walz, as well as a video chat with Pete Hegseth.

During the phone call between President Trump and Mike Walz, President Trump yelled at Mike Walz about "that fraud Goldberg" and demanded that necessary steps were taken immediately to find Goldberg, seize all information he had regarding the Yemen attack Signal communication, and to possibly arrest Goldberg for hacking and espionage.

Several minutes after President Trump spoke with Mike Walz, he held a video call with Pete Hegseth which one additional confidential informant witnessed, as well as a trusted insider aka Mar-a-Lago employee who brought President Trump a diet coke and some food. The conversation between President Trump and Pete Hegseth was both tense and congratulatory. Both confidential informants and the insider said that Hegseth was holding what looked to be a beer during the conversation, and that Hegseth was visibly intoxicated. A few moments later, the insider stepped away to continue working, and both confidential informants continued to observe the video call as President Trump told Hegseth that he was pissed about "a fake piece of shit reporter" being on the signal chat, but that it was being handled. President Trump then went on to congratulate Pete Hegseth on the attack before Hegseth said he had to go and abruptly ended the video call while looking like he was going to throw up due to a gesture and movement he made.

Shortly before dinner was served, one confidential informant had an opportunity to speak with Stephen Miller who was quite intoxicated, and had just been slapped across the face by a young female guest after Miller had made an inappropriate sexual remark. The confidential informant asked Stephen Miller about the Yemen attack and the Signal chat. Miller told the informant that the attack went as planned, but there was a major screw up involving the Signal chat due to either Mike Walz or Marco Rubio including a reporter on the chat which consisted of highly classified information. The informant asked Stephen Miller if he could elaborate, and Miller said that President Trump suspected that Marco Rubio intentionally included the reporter for the sole purpose of

embarrassing President Trump and Pete Hegseth because Marco Rubio is unhappy with the current administration.

After dinner out on the patio, another confidential informant embedded at Mar-a-Lago had an opportunity to have a conversation with Elon Musk, while the informant's young daughter played with little X.

The informant joined the conversation with Elon Musk who was talking with Donald Trump Jr. and a secret insider who is also a close Trump family friend. Elon Musk was bragging about doge and all the money that has been transferred from government accounts to overseas accounts in Switzerland, Russia and Great Britian. The insider asked Elon Musk about the supposed five-thousand-dollar checks being sent out to the public, and Musk said "that is a bunch of bullshit. If the public thinks I am going to give them five thousand dollars, and if some morons in Wisconsin think I am going to give them a million dollars, that is their stupidity.

Donald Trump Jr. then began discussing Tesla, and Elon Musk started to laugh. Both the confidential informant and the insider asked Musk what was so funny, and Elon said, "my plan worked, setting fires and destroying my Telsas, dealerships and charging stations worked so well that AG Bondi was actually able to arrest some people who set their own fires, and she was able to arrest people who did absolutely nothing".

When the insider asked Elon to explain what he was talking about regarding AG Bondi, Musk said that President Trump, AG Bondi and FBI Director Kash Patel set in motion a plan to frame and arrest innocent people when my own employees burned and vandalized.

Later in the evening, a confidential informant who is friends with Marco Rubio, had the chance to have a long conversation with him. The informant who had been advised via text message by another informant that Rubio was unhappy with the administration and that Rubio may have been suspected of adding a reporter to the Signal conversation. Before the informant was even able to get a word out, Secretary Rubio blurted out "I cannot believe that Trump is stealing millions of dollars so people can have dinner with him tonight". asked President Trump How are we going to handle Hegseth bringing his wife into classified high level meetings, and added, personally I would not worry about it. She is a moron. Little X is smarter then she is. President Trump told Elon Musk that he was not very pleased with Hegseth, but he has no choice but to defend him at the moment.

In route from Andrews AFB to Pituffik Space Base, Greenland, a highly confidential insider whose role we cannot divulge, had an opportunity to speak with Vice President JD Vance and Second Lady Usha Vance briefly.

Pursuant to the protections enshrined in the United States Constitution, federal statutory law, and judicial precedent, this declaration affirms that all investigative actions undertaken by Hudsucker Nexis Industries in relation to the document known as *The Hudsucker Papers* were conducted in full compliance with applicable law and protected institutional doctrine.

I. Constitutional Authority and Protected Conduct

- First Amendment (U.S. Const. amend. I): The investigative activities of Hudsucker Nexis Industries are shielded by the constitutional guarantees of free speech, free press, and lawful petition. The use of confidential informants and trusted insiders is a protected method of institutional inquiry, affirmed by *Branzburg v. Hayes*, 408 U.S. 665 (1972), which upholds the right to gather information through lawful means.
- Fourth Amendment (U.S. Const. amend. IV): No unlawful search or seizure occurred. All materials were obtained through voluntary disclosure, whistleblower channels, or public access, with no breach of privacy or unauthorized surveillance.
- Fifth Amendment (U.S. Const. amend. V): No coercion, self-incrimination, or deprivation of due process was involved in the acquisition or handling of the document.

II. Statutory Compliance and Whistleblower Protections

- Whistleblower Protection Act of 1989 (5 U.S.C. § 2302(b)(8)): Trusted insiders who disclosed information did so under protected status, shielded from retaliation and in service of public interest.

Hudsucker Nexis Industries did not solicit illegal acquisition, and its review is shielded under this precedent.
- United States v. Aguilar, 515 U.S. 593 (1995): Clarifies the boundaries of obstruction and intent. No action taken by our team meets the threshold of corrupt intent or unlawful interference.

IV. Sovereign Legitimacy and Institutional Mandate

Hudsucker Nexis Industries operates as a sovereign investigative ministry under the ceremonial and legal umbrella of GIMBEL & GAMBLE LLC — a legacy-grade digital republic with ministries spanning media, law, and public service.
